CENTRAL COAST MARINERS "BRING A MATE THROUGH THE GATE" TERMS AND CONDITIONS 2023-24

INTRODUCTION

As a CC Mariners Pty Ltd (ABN 84 618 563 134) (**Central Coast Mariners**) Season Ticket holder, and a registered customer with MATE Communicate Pty Ltd (ACN 165 670 413) (**MATE**) you may be eligible for an additional ticket to a home game during the 2023-24 A-League season, pursuant to the Terms and Conditions.

These terms and conditions form part of and are ancillary to your Membership Agreement.

1. DEFINITION

1.1 In these Terms and Conditions, unless the context requires otherwise:

MATE has the meaning given to that term in the Introduction.

Membership Agreement means the membership agreement between you and CC Mariners Pty Ltd ABN 84 618 563 134.

Offer means the offer to all Members who are also MATE customers to register to receive a free ticket to home games.

Terms and Conditions means these 'Bring a Mate through the gate" terms and conditions.

1.2 In these Terms and Conditions, any term that is not defined herein will import the meaning of that term as defined in the Membership Agreement.

2. ELIGIBILITY

2.1 Eligibility Requirements

- 2.1.1 These Terms and Conditions and the Offer only applies to current Season Ticket Holders who are also a connected MATE customer.
- 2.1.2 If at any time you cease to be a Member, or a connected customer of MATE, you will no longer be eligible to receive the Offer.
- 2.1.3 You acknowledge that Central Coast Mariners and MATE may, upon prior notice to you, introduce additional or other eligibility criteria from time to time and that such additional criteria will form part of these Terms and Conditions.

2.2 Verification of Eligibility

- 2.2.1 You acknowledge and agree that:
- 2.2.1.1 Central Coast Mariners will provide your membership details and information to MATE; and
- 2.2.1.2 MATE will provide Central Coast Mariners with information in relation to your MATE account, to confirm your eligibility to receive the Offer.
- 2.2.2 By agreeing to these Terms and Conditions, you consent to the sharing of your personal information between Central Coast Mariners and MATE in order to verify your eligibility to participate in the Offer. For the avoidance of any doubt, in the event that you withdraw your consent, your eligibility to participate in the Offer shall be withdrawn and/or terminated as and from the date such consent is withdrawn.

2.3 Confirmation and Acceptance

- 2.3.1 Once you successfully register to receive the Offer, and your eligibility has been verified, the Bring a MATE through the Gate promotion will be added to your membership profile.
- 2.3.2 The promotion will permit you to acquire an additional ticket to a Home Match at no further cost.

2.4 Right to refuse

- 2.4.1 Central Coast Mariners reserves the right to refuse the Offer to any person at its absolute discretion.
- 2.4.2 We will assess your eligibility on a weekly basis and, if you are no longer eligible to receive the Offer, we will disable and remove any active pass or code from your account without notice to you.

3. FURTHER CONDITIONS

3.1 Redemption

Prior to each match, eligible members will redeem their digital code via Ticketek. You will then need to use this code when prompted when purchasing a ticket.

3.2 General

- 3.2.1 Nothing in these Terms and Conditions is intended to vary the Membership Agreement and, in the event of any inconsistency between the Terms and Conditions and the Membership Agreement, the latter will supersede and prevail over the former to the extent of any inconsistency only.
- 3.2.2 All other terms contained in the Membership Agreement shall continue to apply to you and the additional ticket holder.
